THE SEMINAR

THE SPEAKERS

Dato' W.S.W. Davidson is a vastly experienced legal practitioner and arbitrator. He has also had extensive experience in arbitration as counsel. Having been in active legal practice in Malaysia since 1964, he is currently a consultant with Azman Davidson & Co. He is a fellow of the Chartered Institute of Arbitrators, United Kingdom and of the Malaysian Institute of Arbitration, Dato' Davidson is a member of the Bar Council Committee on arbitration and the arbitration committee of the Malaysian International Chamber of Commerce and Industry.

He has acted as arbitrator in three-man panels in international arbitrations under the UNCITRAL rules, single arbitrator and member in three-man panels in domestic arbitrations under various arbitral regimes and as panel member of arbitrators in the Kuala Lumpur Regional Centre for Arbitration.

Tan Sri Dato' Cecil Abraham, Senior Partner with Zul Rafique & Partners, is a Barrister-At-Law of the Middle Temple and graduated with an LL.B. Hons from Queen Mary College, University of London. He is a Chartered Arbitrator and a Fellow of the Chartered Institute of Arbitrators U.K., Malaysian Institute of Arbitrators, Singapore Institute of Arbitrators and the Australian Centre for International Commercial Arbitration Limited. He is involved as Counsel and Arbitrator in more than 100 arbitrations under the ICC, SIAC, KLRCA, LCIA and ICSID Rules and also in Ad Hock Arbitrations. He is a Member of the ICSID panel and the Permanent Court of Arbitration.

Mr Sundra Rajoo is currently the Director of the Kuala Lumpur Regional Centre for Arbitration. He is a Chartered Arbitrator, an Advocate & Solicitor of the High Court of Malaya (non-practising) and had earlier practised as an Architect and Town Planner. He is the founding President of the Society of Construction Law (KL & Selangor), Past Chairman of the Chartered Institute of Arbitrators and Past Council Member of the Malaysian Institute of Architects.

He has been appointed as chairman, co-arbitrator of three-man panels and sole arbitrator in various ad hoc and institutional international and domestic arbitrations. Some of the institutional arbitrations include those such as the International Chambers of Commerce (ICC), the Chinese International Economic Trade and Arbitration Commission (CIETAC), Singapore International Arbitration Centre (SIAC), Regional Centre for Arbitration Kuala Lumpur (KLRCA) and Palm Oil Refineries Association Malaysia (PORAM). Thus far, he has had over a hundred and fifty appointments as arbitrator.

Dr. Christian Dorda is founding partner of DORDA BRUGGER JORDIS and has been specializing in international commercial arbitration. He acted as a member of the ICC International Court of Arbitration, is the vice-chairman of ICC Austria and is regularly sought as an arbitrator in institutional or ad hoc arbitral proceedings.
